



## Rules and Requirements

**ELIGIBILITY:** The JourneyForth 2024 Summer Reading Challenge is open only to legal residents of the fifty (50) United States and the District of Columbia. Parents or guardians who are 21 years of age or older may enroll their child(ren), ages 4-17, in the reading challenge. Any entries not eligible for any reason will be disqualified from winning the prize(s). Employees of BJU Press and their immediate family members are not eligible to enter prize drawings. Void where prohibited by law. All applicable federal, state, and local laws apply.

**HOW TO ENTER:** Beginning June 1, 2024 through August 19, 2024, parents/guardians may sign up their children at [bjupresshomeschool.com/summer-reading](http://bjupresshomeschool.com/summer-reading). To be eligible for prizes, participants must read 15 minutes per day for 40 days between June 1, 2024 and August 19, 2024; days do not need to be consecutive. No purchase necessary. Upon completion of the reading requirement, parents/guardians must complete the challenge completion form on or before August 19, 2024 in order for their students to receive a completion prize and to be eligible for the prize drawings. Limit one (1) entry per drawing per participant.

**PRIZE AND ODDS:** While supplies last, students who complete the JourneyForth 2024 Summer Reading Challenge will receive a prize pack containing two (2) items. Five (5) weekly prize winners will be chosen at random from the pool of completion form submissions on July 17, July 24, July 31, August 7, and August 14, 2024. Each weekly winner will receive one (1) JourneyForth title (\$7-9 value). Within each age group, three (3) grand prize winners will be chosen at random on August 21, 2024; the grand prize winners will receive one (1) tote bag and five (5) JourneyForth novels (\$50 value). All prize details are at the sole discretion of BJU Press. The odds of winning will depend upon the number of eligible entries received.

**RANDOM DRAWING WINNER NOTIFICATION:** Winners for the weekly book drawings and the grand prize drawing will be notified by email. If necessary, alternate potential winner(s) may be selected by random drawing from among all remaining eligible entrants. Winners' first name and last initial will also be announced on JourneyForth's social media pages.
